## Picnic Area Rules and Regulations

For everyone's safety and enjoyment, you must follow these rules and regulations.

- As the permit holder, you must be 21 or older and remain on site.
- Do not bring alcoholic beverages into the forest preserve; they are strictly prohibited.
- Keep your site clean and dispose of trash in the appropriate garbage or recycling containers.
- Stay with your pets at all times. Always keep them leashed and quiet, and pick up any pet waste.
- Do not start any ground fires.
- Do not bring or use horseshoes, piñatas, egg-toss games, water balloons, animal rides, dunk tanks, moon walks, musical performers, disc jockeys, stages, tents or trampolines.
- Use generators, stereos and similar equipment only at volumes that do not disturb other visitors.
- Follow all Forest Preserve District of DuPage County ordinances, state statutes and administrative orders. The Forest Preserve District may modify these rules and regulations at any time.

By signing this application, I agree to present my permit for inspection to a Forest Preserve District of DuPage County agent if asked. I also agree to abide by the above rules and regulations while using the picnic site. The information I've provided on this application is true. I understand that if I supply false information or do not comply with the above rules and regulations the Forest Preserve District of DuPage County may fine me or revoke my permit without refunding my permit fee.
