- One lot of five metal military green ammo boxes.



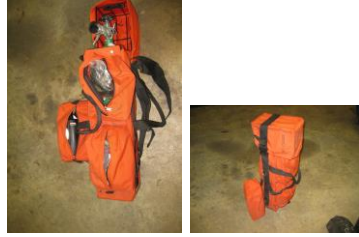
