Board Meeting Minutes Tuesday March 21, 2023

The board meeting of the Friends of the Forest Preserve District of DuPage County was held on Tuesday, March 21, 2023, at the District headquarters.

Call to Order

The meeting was called to order by Chairman Diane Addante at 5:01 pm.

Roll Call

Present: Diane Addante; Bob Watt; Carl Schultz; Penny Chanez; Karyn Charvat; Larry Larson; Dave Stang; Joe Suchecki; Mike Dyer. Commissioner Jeff Gahris Ashley Guest joined midmeeting.

Approval of Minutes - The minutes from the January 24, 2023 Board of Directors Meeting were accepted as written by general consent and placed on file. Motion Penny Chanez 2nd Karyn Charvat.

Board Chair Report Chairman Addante

- Introduction of staff Jeannine Kannegiesser; Audra Bonnet; Lulu Hertenstein
- Spring Appeal and Giving DuPage Days Chairman Addante noted the Spring Appeal focused on supporting the Willowbrook Wildlife Center. We have had 71 donors, 32 of which have given more than \$100. There were 2 large donations, \$57,000 for Mayslake and \$50,000 for Willowbrook. We have a 41% donor retention. Giving DuPage Days are May 1-May 5. Each board member has an individual page to use to support this effort.

Mission Moment – Mayslake Peabody Estate Restoration update Chris Lamarca's video presentation was shared with the Friends' board, providing an update on the Mayslake Hall project. Presentation began with a brief history of the hall and how it came into the District's possession. In 2019 the District developed a Master Plan including money for Mayslake. This included Rehabilitation of the exterior masonry, window woodwork, and parking lot. In 2020 the west parking lot was improved. In June of 2022 the District hired Klein Hoffman Bahn to develop restoration. Upcoming events at Mayslake are the District Plant Sale May 18-May 20, Garden Restoration August, and Art Exhibit September 7.

Shop Our Popular Native Plant Sale

Gardeners are invited to shop the <u>Forest Preserve District of DuPage County's</u> popular <u>Native Plant Sale</u> held from 10 a.m. to 7 p.m. on Friday, May 19 and from 9 a.m. to 2 p.m. on Saturday, May 20 at <u>Mayslake Peabody Estate</u>. (If you purchased a presale ticket for shopping on Thursday, May 18, please be prepared to show your ticket receipt at check-in no more than 10 minutes before your purchased ticket timeslot.)

Shoppers can get gardening advice from District plant experts at the sale, which will feature five new species this year. A <u>list</u> of anticipated native flowers, grasses, trees, and shrubs is available on the District's website, but actual inventory will be based on supplier availability. Plants are not restocked each night.

Shoppers are encouraged to bring their own boxes and wagons to transport their plants. Cash, credit, and checks will be accepted.

All plants for sale will have originated from seed collected within 100 miles of DuPage County and will be free of insecticides containing neonicotinoids, which are harmful to bees and other pollinators.

All proceeds from the sale go to support educational programming at the Forest Preserve District.

Gardeners can also pick up <u>free wood chips</u> on Saturday, May 20 from 8 a.m. to 1 p.m. at the Forest Preserve District's <u>native plant nursery</u> at <u>Blackwell Forest Preserve</u>. Individuals may fill one pickup truck or smaller vehicle; contractors are not allowed. A District employee will be on hand with a tractor to help fill trailers and truck beds. People who want smaller amounts should bring their own shovels and containers.

Willowbrook Wildlife Center continues to be the resource our community turns to for wildlife rescue advice. If you find a wild animal exhibiting signs it needs help, visit our <u>website</u> to help determine if it requires assistance.

Willowbrook may have species-specific admission criteria. In the case where an animal does not meet that criteria and is unable to be treated at Willowbrook, the center may be able to help concerned rescuers find other licensed wildlife rehabilitators.

We'd also like to thank our 50 donors who made gifts during <u>Giving DuPage</u> <u>Days</u> to support Willowbrook and injured and orphaned native wildlife. We are grateful for your generosity to help provide general examinations, X-rays, bloodwork, and specialized care for injured animals and rear orphans.
