Friends of the Forest Preserve District of DuPage County Board of Directors Meeting July 26, 2022

A Meeting of the Friends of the Forest Preserve District of DuPage County Board of Directors was held on Tuesday, July 26, 2022 at the District Office of the Forest Preserve of DuPage County.

The meeting was called to order at 5:02 pm by Chairman Diane Addante.

Roll was called with the following result:

Approval of Minutes – The minutes from the May 24, 2022 Board of Directors Meeting were accepted as written by general consent and placed on file.

Chairman's Report – Chairman Addante thanked everyone for attending. She shared current donation information. Fundraising thus far has acquired \$255,000, 235% over the same period last year. This is driven by three major gifts. Our donor retention rate is 38%. We have had 371 new donors this year. The Friends have received 70 donations of \$500+, versus 33 last year. So far, four board members have made financial donations to the organization.

Committee Reports

<u>Finance Committee</u> – Chairman Addante presented the Financial Dashboard through 6/30/22, highlighting Assets Less Liabilities of \$946,259.62, Net Income of \$221,894.88, comparisons of Profit & Loss Budget vs Actual and Unrestricted Funds of \$160,582.95 vs \$102,939.39 last year.

It was moved by Carl Schultz and seconded that we accept the Financial Dashboard Summary and Profit & Loss Budget to Actual Report through June 30, 2022. Motion Adopted.

We then reviewed the memo from Andrew Brown, Director of Finance, requesting \$128,552.16 from donations received by the Friends, to reimburse the District for expenditures previously incurred for the programs as stipulated by the donors. This included \$100,000 for Willowbrook Wildlife Center for operations/care of animals.

It was moved by Larry Larson and seconded that we approve the transfer of \$128,552.16 to the Forest Preserve District of DuPage County for reimbursement of expenditures, including \$100,000 for Willowbrook Wildlife Center animal care. Motion Adopted.

Mr. Schultz requested information on government I Bonds. The Finance Committee will follow up.

<u>Development Committee</u> —Jeannine Kannegiesser reported on the roll out of the Willowbrook Wildlife Center fundraising campaign. The proposed goal for the campaign would be \$500,000 over two years. Mr. Vogt stated that fundraising was an understood part of our organization and the project would result in great visibility. Chairman Addante asked for clarification of what would be expected of board members. Answer: Personal donations, acquiring donors and sharing the campaign were the main expectations. Each board member would have their own individualized goals. If we acquire corporate donors, those funds would be credited to the board member who garners the support. Commissioner Gahris noted that focusing on the animal care aspect should be appealing to our base. Ms. Kannegiesser reported that in discussing the campaign with several of our supporters, it was a very easy sell. Board support of a "Challenge Fund" would be a great message from us.

Since we were missing several board members, we agreed we would revisit the topic at our September meeting and vote on the issue at that time.

In the meantime, Ms. Kannegiesser asked that all board members contact her with campaign thoughts and questions.

Bob Watt reported on the Development Committee meeting on 6/21/22. The committee discussed the Willowbrook campaign and the search for prospective new board members.

Mr. Watt then discussed the potential \$20,000 grant for area dog parks from a corporate donor that has a program to partner with municipalities to support pet friendly cities. To pursue the grant will require the Friends to collaborate with one of our municipalities to help them be certified as pet friendly. There is possibility for future financial support after the initial grant period. The grant deadline is the end of August. If we can secure partnership in time, we will pursue this year. If not, we will work towards this for 2023. Commissioner Gahris suggested Glendale Heights since there are opportunities for improvement in a park there.

<u>Event Committee</u> –Ms. Hertenstein shared that the Night for Nature is moving forward. We will be using Belgio's Catering. Entertainment will include Heather Chrisler, Artistic Associate at First Folio Theatre performing "Musings on Autumn" and the music of Anderlik, Roach and Church from 5-9 pm. The Wheaton Lion's Club will again sponsor the \$500 prize for the Duck Race, Wheaton Bank and Trust has provided a sponsorship of \$2,500 and the Conservation Foundation has donated \$500 toward the event. Tickets go on sale starting 8/1 and we hope to sell 150. We have several substantial prizes already for the Silent Auction and Kathy Isoda, a volunteer at St. James Farm, is gathering favors for attendees. The letter for auction items will be re-sent to board members.

Staff Liaison and Ex-Officio Reports

Ms. Kannegiesser reported that she will soon be giving a six-month update to the Board of Commissioners and asked if some Friends members would come. The District is pursuing numerous grants for restoration and also working on the Year-End Appeal and Giving Tuesday campaign. District budgeting for 2023 is in progress. Nancy Kett, a volunteer at Willowbrook, provided lovely artwork for thank you cards for our use.

Commissioner Gahris thanked the Board for approving the \$100,000 reimbursement for care of the animals at Willowbrook. Construction there is running into delays over permits, but looking forward to getting started building the homes for the animals. Costs may be higher than expected for the first phase, but the fixed price contract with the builder shifts those costs to the builder.

The Board of Commissioners recently approved a study by the Delta Institute to begin work that will ultimately lead to a Clean Energy, Resiliency and Sustainability plan for the District. Of major import will be energy consumption and carbon emissions. This is a great planning tool for projects going forward.

The solar panel installation is underway. Supply chain issues are delaying the arrival of inverters, so it is not yet electrified.

Finance Department

Director Andrew Brown noted that there is a change of timing in the District's draw of money from Friends. Instead of quarterly, it will occur twice a year, in June and at year-end. A significant draw for the solar panels will be needed and funds for Willowbrook, both capital and operating, will be requested when needed.
